### SUMMARY

As of June 30<sup>th</sup> 2006, CECILIA web page has been established at <http://www.cecilia-eu.org/>. The page provides basic information about the project, its aims and (expected) results, as well as information needed by the participants.

### PAGE STRUCTURE

The page's purpose is to present the project and to disseminate its results. In order to allow for presentation of information and data with different degree of confidentiality, there are three levels of access, two of them protected by password:

- **The public section** is freely accessible. This section provides general information about the project and its aims, including project objectives, introduction of participating institutions, public project documents including the respective presentations and information about project-related meetings. As individual deliverables are finalized during the project, they will also appear here. The current organization of the public section of CECILIA webpage is as follows:
  - **Introduction** – basic information about the project,
  - **News** – recent project-related information,
  - **Description** – CECILIA objectives, aims and goals, relations to other projects, overview of the scientific frame of the project,
  - **Structure** – organizational structure, description of individual workpacackages,
  - **Participants** – participating institutions,
  - **Documents** – basis project documents and, in the future, produced public publications,
  - **Meetings** – information on project meetings,
  - **Links** – other projects, sites and materials of interest,
  - **Contacts** – contact information.

This structure can change in the future to better suit the needs of the project.

- **The restricted section** contains material intended for the European Commission and participants, which currently means completed deliverables before they are made public.
- **The participant section** contains materials intended solely for the project participants, such as internal project documents and details of the administrative status of the project. Later, interface allowing upload of files by participants will be included.

### TECHNICAL MAINTENANCE

The domain **cecilia-eu.org** has been registered by the coordinating institution (Charles University) and paid for 10 years. The page is hosted at the server maintained by the Department of Meteorology, Faculty of Mathematics and Physics, Charles University. Contents of the page were prepared by Jiri Miksovsky and Michal Belda, who are also providing its updates and general maintenance.
